#### (15) Description of equipment:

The CP20 series of power supplies are industrial grade DIN-rail mountable switch-mode power supplies in the 480W power class. They are designed for single-phase input voltages between AC 100V and AC 240V and provide a floating, stabilized and galvanically separated SELV/PELV output voltage.

All models optional with suffix -C1 for conformal-coated pc-boards.

Revision 2: Re-testing due to technical changes on model CP20.241-R2-72 and CP20.241-R2-73 Output current was reduced to 22 A at 45 °C due to design changes (see ratings below).

Revision 3: Update of current version of standards. Update of TRF (ExTR) to current version of standards used. Revision of manufacturer's documents. New model added: CP20.245-R2 (identical to model CP20.241-R2-73 of Revision 2 without conformal coating).
